Business Space

Choosing the right physical (or virtual) setup for your career coaching business is a strategic decision that will affect your brand, budget, operations, and client experience. Here's a breakdown of the **pros and cons** of three common options: **co-working space**, **standalone office**, and **telehealth/virtual platforms**.

1. Co-Working Space

Pros:

- **Cost-effective:** Typically cheaper than leasing your own office. You pay for what you use.
- **Flexible terms:** Month-to-month options are common.
- **Networking opportunities:** You're surrounded by other professionals, which can lead to referrals or partnerships.
- **Amenities included:** Internet, printing, coffee, meeting rooms, etc.
- **Professional setting:** Great for occasional in-person meetings without long-term commitments.

Cons:

- **Lack of privacy:** Shared spaces can limit confidentiality or create distractions.
- **Brand identity:** Limited ability to customize the space to reflect your brand.
- **Availability:** May need to book rooms ahead of time, especially for private meetings.
- **Noise/distractions:** Even with private rooms, some co-working spaces can be noisy.

2. Standalone Office (Leased or Owned)

Pros:

- **Privacy and control:** Ideal for confidential coaching sessions and HIPAA compliance if needed.
- **Brand presence:** You can create a space that reflects your values and professionalism.
- **Consistency:** Clients come to the same location, which can build trust and routine.
- **Scalability:** Easier to expand as your business grows.

Cons:

- **Higher cost:** Lease, utilities, insurance, and maintenance add up quickly.
- **Long-term commitment:** Often requires a multi-year lease.
- **Responsibility:** You handle everything—furnishing, cleaning, compliance, etc.
- **Location dependence:** Limits access for clients outside your area.

3. Telehealth/Virtual Platforms

Pros:

- **Low overhead:** No rent, utilities, or travel time.
- **Flexibility:** Serve clients anywhere, increase scheduling options, and work from home or while traveling.
- **Accessibility:** Clients with mobility, transportation, or time constraints may prefer virtual sessions.
- **HIPAA-compliant platforms:** Tools like SimplePractice, Zoom for Healthcare, or Doxy.me meet privacy standards.

Cons:

- **Technology barriers:** Some clients may struggle with tech or lack private space for sessions.
- **Reduced personal connection:** Building rapport can be harder online for some coaches/clients.
- **Distractions:** Both coach and client may experience home interruptions.
- **Licensing restrictions:** If you also offer counseling, you'll need to follow state-specific licensure laws.

Questions to Guide Your Decision

- Who is your **target audience** (location, comfort with tech, preference for in-person)?

- What is your **budget** for startup and recurring costs?
- Do you want to keep **overhead low** while testing the market?
- Are you planning to **scale or stay solo**?
- How important is **branding and control over the environment**?

Liability Insurance

- Liability Insurance protects you in the event you get sued or encounter legal issues. They often provide legal consultations as part of your premiums.
- NCDA is a sub-division of American Counseling Association and if you are a member of both you can get a discount from [HPSO](#). Check with other professional associations you are a part of to see if they have liability insurance provider referrals.

Tax planning

- The best advice is to speak with a tax professional.
- The [Small Business Administration](#) has some guidance on this topic.

Grants

Government grants are typically for non-profit organizations and are not available to for-profit private practices. Occasionally, non-profit organizations receiving grants can hire private practice practitioners as part of their grant.

Occasionally, small grants can be secured through local community foundations or professional associations. Private investors could also be an option for securing grants.

Established private practices with good credit could qualify for small business loans through banks. However, loans are meant to be paid back, unlike grants.

Collecting Payment options & Software

There are tons of options, choose one that works for you. Many of the coaching and counseling platforms integrate a payment system.

Some of the biggest name systems are PayPal, Stripe, Venmo, and Zelle.

Considered the world's largest online professional network platform, LinkedIn is open to anyone globally and allows account holders the opportunity to showcase their professional stories for free. Although the platform offers a premium paid plan with more benefits, the free plan is well-suited for everything you need as a career professional.

LinkedIn is an excellent option for new NCDA Instructors or career practitioners to launch their businesses or services.

Best Practices: Key Uses Thought Leadership & Networking

- **Optimize Your Profile:** Be cognizant that your profile reflects you and your business. Use a professionally taken headshot or a photo that represents professionalism.
- Introduce yourself or your business with an engaging and impactful headline.
- Remember that LinkedIn offers professional (personal) and business options, so make sure the headline reflects your purpose for having a page.
- Invest time and thought in your personal or business summary. Make sure to craft a compelling story that draws you in and is client-centered. Remember to ensure your story is SEO-optimized and showcases your skills and value.
- Endorsements are significant. Think about Google reviews and their impact. Your endorsements can provide credibility to your story and resume.
- **Engage with Content:** Once all the above is in place. Network. Post career trends and career tips, and add your professional insights. Build credibility by sharing client success stories if you have them (with permission) or post a case study. If you have your own, great; if not, react to another (respectfully). Join AND participate in groups to position yourself further as an industry go-to expert.

- **Leverage LinkedIn Articles & Newsletters:** Write long-form content on your niche and related career thought pieces.
- **Utilize LinkedIn Live & Events:** Host Q&A sessions, career workshops, courses, and webinars to drive engagement.

Make sure what you do on LinkedIn is duplicated in form on all your other social media sites.

Online meeting software

Skype (Microsoft)

- **Encryption:** Uses **TLS** and **AES** to encrypt data in transit. **End-to-end encryption (E2EE)** is only available in “Private Conversations” and must be initiated.
 - **HIPAA Compliance:** Skype is **not generally HIPAA-compliant** and Microsoft will **not sign a BAA** for standard Skype services.
 - **Considerations:** Not recommended for confidential client work unless using Private Conversations and you do not require a BAA.

Recommendations for Career Coaches

- If you are bound by HIPAA or want to **ensure maximum privacy** for sensitive client conversations, **Zoom (with Healthcare plan)** or **Microsoft Teams (with BAA)** are your best bets.
- For **general coaching without HIPAA requirements**, Google Meet (via Workspace) is a solid, user-friendly choice.
- Avoid regular Skype for confidential coaching unless you're using encrypted Private Conversations and don't require a BAA.
